<p><b>14</b> Yes</p>	<p>Issues \$5.5 billion in bonds for state stem cell research institute</p> <p><b>Consensus: YES</b></p>
<p><b>15</b> Yes</p>	<p>Requires commercial and industrial properties to be taxed based on market value and dedicates revenue</p> <p><b>Consensus: YES</b></p>
<p><b>16</b> Yes / No</p>	<p>Repeals Proposition 209 (1996), which says that the state cannot discriminate or grant preferential treatment based on race, sex, color, ethnicity, or national origin in public employment, education, or contracting</p> <p><b>Undetermined</b></p> <p>Opponents say we don't need it. Allows government decisions can take diversity into account. Allows diversity as a factor. Allows diversity in hiring/contracting. Democratic Party, LWV – YES Republican Party - NO</p>
<p><b>17</b> Yes</p>	<p>Restores the right to vote to people convicted of felonies who are on parole</p> <p><b>Consensus: YES</b></p>
<p><b>18</b> Yes</p>	<p>Allows 17-year-olds who will be 18 at the time of the next general election to vote in primaries and special elections</p> <p><b>Consensus: YES</b></p>
<p><b>19</b> Yes / No</p>	<p>Changes tax assessment transfers and inheritance rules</p> <p><b>No Consensus – leaning YES</b></p> <p>Democratic Party - Yes Republican Party – no position LWV - NO</p>

	<p>In favor reflects inheritance tax changes that equalize wealth to combat racial inequalities. Property tax – inherited house must be primary residence or taxes will be reassessed. 55+ can keep low tax rate for 3 home purchases.</p>
<p><b>20</b> No</p>	<p>Makes changes to policies related to criminal sentencing charges, prison release, and DNA collection</p> <p><b>Consensus: NO</b></p>
<p><b>21</b> Yes / No</p>	<p>Expands local governments' power to use rent control</p> <p><b>Undetermined</b></p> <p>Modifies 1995 law. Not a housing solution, just a band aid. Positive but not perfect. Rent control – “vacancy de-control” Modify Costa Hawkins of 1995. Rent control for properties (built before 1995 is exempt). This would change the rule to over 15 years old is exempt. If your city already had rent control when CH passed, you were exempt. Cities have more latitude. Applies to prop owners &gt;2 properties. Caused displacement with people of color. 15% increase each year for first 3 years after de-control. Rent control caps at 5% + inflation.</p> <p>Democratic Party: YES Republican Party: NO LWV – Neutral</p>
<p><b>22</b> Yes / No</p>	<p>Considers app-based drivers to be independent contractors and enacts several labor policies related to app-based companies</p> <p><b>Undetermined. To force Uber, Lyft and other driving apps to follow CA AB5 Independent Contractor law, Vote NO</b></p> <p>Funded by Uber, Lyft, and other apps. The Uber rule. Strict requirements for having independent contractors. Cant perform the same work the company provides. App based drivers are exempt. Not all indep contractors want to be employees with benefits. May decrease the availability of drivers – drunk drivers won't have driver options. Cost passed on to customers. A vote against means the drivers cannot be ind contractors – follow AB 5. Independent contractors MAY have reduced wages to pay for benefits. No consensus on what drivers want.</p> <p>Democratic Party: NO Republic Party: YES LWV: No position</p>

Requires physician on-site at dialysis clinics and consent from the state for a clinic to close

Cash bail. Consider safety – you may not have bail as an option. Algorithm to determine flight risk and assess risk level. SB10 would be repealed with a no vote.  
YES vote for computerized algorithm as input by humans. Humans can be discriminatory.

<p><b>B</b> Yes</p>	<p>Replace the Community Review Board with an Independent Commission on Police Practices (Introduced by Women Occupy San Diego)</p> <p><b>Consensus YES</b></p> <p>No argument against.</p>
<p><b>C</b> Yes / No</p>	<p>Amendments to San Diego City Charter to Establish District-Only Elections for Members of the Board of Education of the San Diego Unified School District.</p> <p><b>Undetermined</b></p> <p>Republican Party, Democratic Party, LWV – YES</p> <p>District-only elections for School Board. Can't vote in other districts.</p>
<p><b>D</b> Yes</p>	<p>Charter Amendments to Provide Procedures for Filling Vacancies, Removal for Cause, and Succession to Office for Members of the San Diego Unified School District Board of Education</p> <p><b>Consensus YES</b></p> <p>No argument against.</p>
<p><b>E</b> Yes / No</p>	<p>Amend Municipal Code to Exclude the Midway-Pacific Highway Community Plan Area from Coastal Zone Height Limits (Proposed by councilmembers Chris Cate and Jen Campbell)</p> <p><b>Undetermined – leaning towards YES</b></p> <p>Republican, Democratic, LWN – YES</p> <p>Opposition concerned about unspecified height limit and environmental impact. YES vote removes 30' Height limit in Midway/Sports Arena district for new construction development.</p> <p>Opposition concerned about creating a heat island. Under water in 30 years. No environmental impact studies per Mayor Faulconer.</p>
